PROGRAM COVER CONTEST

The 2024 Career Technical Education Fall Conference Committee is seeking entries from middle and high school CTE students for the conference program cover design. The Career Technical Education Fall Conference brings together educators to share innovative practices that encourage and empower students to excel.

OFFICIAL RULES FOR THE COVER CONTEST

1. Students currently enrolled in a Career Technical Education (CTE) Media Production or Design, Visual and Graphic Arts or Graphic Production Technologies pathway course are eligible to submit **ONE** entry. The maximum number of entries is limited to **ten (10) per teacher**.
2. All entries must reflect the information in the three (3) header lines of this announcement and, in addition, need to include **1)** the **CTE Logo**, which can be downloaded from the CTE Fall Conference website (cteconference.org), **2)** the dates **November 20-22, 2024** and **3)** location of the conference: **Omni Rancho Las Palmas**.
3. Entries must be computer-designed using colors selected by the student.
 - a. Entries must be submitted on 8 1/2 x 11 white paper (not mounted) and with the fillable PDF entry form attached by staple-no paperclips. (The program will be printed on white stock.)
 - b. The top three winners will be required to submit their work electronically. The first place winner may be requested to edit their work by the committee and provide CYMK numbers.
4. All entries will be judged on:
 - a. Spelling (NOTE: All entries with misspellings will be disqualified).
 - b. Meeting all criteria of this contest
 - c. Creativity and the effective use of color
 - d. Craftsmanship, clarity, and neatness
 - e. Ability to be effectively printed/reproduced (jpeg) on white paper
5. Entries must be received by **Thursday, March 21, 2024, 4:00 pm.**, in the office of North Orange County ROP, 385 N. Muller Street, Anaheim, CA 92801. Late or electronic entries will NOT be accepted. Postmarks do not count as received.
6. The winners will be selected by the conference committee and will receive: **first place winner-\$600, second place - \$400, and third place winner-\$200. In addition, up to three Honorable Mention winners will receive \$75.** The first, second, and third place winners will be invited to be recognized in person at the conference where all winners' artwork will be displayed.
7. Winners will be contacted via email. An announcement of the winners will be posted on the cteconference.org website by the end of April.
8. No artwork will be returned.
9. All entries must be submitted with the fillable pdf entry form stapled on the back of the design with the form facing out (**staples only, no tape – no paperclips**) containing all contact information, required signatures of the student, parent/legal guardian (if under 18), and teacher. Handwritten entries or entries without required signatures will not be accepted. Signatures grant the conference committee the right to use the winner's name, entry, and photograph for publicity purposes.
10. Entrants accept and agree to these rules. The decision of the committee shall be final.
11. First place student agrees to make modifications to artwork requested by the conference committee in a timely manner.

After completing the student and teacher information sections, print and obtain student, parent/guardian (if under 18), and instructor signatures. Staple the form to the back of the design with the entry form facing out. Do not use paper clips to attach the entry form. Entries without all required signatures will not be accepted.
